Ms. Heather N. Hardy pulled the matter for further discussion. Mr. Jeffrey Tonner was present to explain that the treating dentist was Dr. Du and not Dr. Song. Ms. Heather N. Hardy made a motion to accept the executive director's decision to terminate, seconded by Dr. Robert B. Taylor. The motion passed unanimously 10 - 0.

The Board took a break from 10:59 a.m. to 11:08 a.m.

ANESTHESIA AND INTRAVENOUS SEDATION

Dr. Gary Shoenrock was present to speak to the board about coming up with results for granting intravenous sedation from another state to practice in Arizona.

Joseph Rodriguez was present to speak about having access to anesthesiologists and has a number of suggestions and, "wants to create a good dialog to reach a good solution."

Chase Sossaman was present to speak about improving safety for permit holders for anesthesiologists and/or allow some sort of committee/group for safety. He believes there should be some sort of permit to receive from the Dental Board and guidelines.

Dr. John Dovgan was present to speak. He spoke about his background and agrees that the Arizona State Board of Dental Examiners should have minimal guidelines and training for anesthesiologist and intravenous sedation permits.

Ms. Savita Chandragiri was present and stated she feels like there should be an amendment to the rules for an anesthesiologist and intravenous sedation to be safe for people. She would like to assist with making a rule change and ensure the construction of the building is safe. Mr. Daniel Shoemaker was present to speak. He spoke about the importance of the safety for the public to have safe buildings. Dr. Daniel Shoemaker also spoke about the Board inspecting the buildings to make sure the anesthesiologist and intravenous sedation specialists are verified for the levels they administer to patients.

Ms. Heather N. Hardy made a motion and recommend to form a committee that is made up of three (3) board members and four (4) public members. Ms. Heather N. Hardy also suggested to have board members, Dr. Anthony Herro, Dr. Lisa B. Bienstock and Mr. Nick Goodman as part of that committee, seconded by Dr. Robert B. Taylor. The motion passed unanimously 10 - 0.

BOTOX AND DERMAL FILLERS

Dr. Gary Shoenrock was present and spoke about Botox and Fillers. He stated that there needs to be a change to statute, A.R.S. § 32-1202 as well as policy changes. He suggested courses and hands on classes to provide botox and fillers to the public. The members spoke about the policy and proposed to allow for statutory change. The board members spoke about public safety. Board staff will submit CV and resumes to the Board for those members of the public who wish to participate on this committee. Ms. Heather N. Hardy made a motion to review the board statutes substantive policy statement regarding administering botox and dermal fillers, the committee will be made of five (5) members, two (2) board members, Ms. Morgan Burg, Dr. John N. Harmon and three (3) public members, seconded by Mr. Nick Goodman. The motion passed unanimously 10 - 0. This agenda item will be scheduled at the next Board meeting.

WESTERN REGIONAL EXAMINING BOARD EXAM

Ms. Mary DeLaat Williams gave an update to board members of the substantive policy. Ms. Heather N. Hardy made a motion to rescind the prior vote and update the substantive policy regarding the exam requirements, seconded by Dr. Robert B. Taylor. The motion passed unanimously 10 - 0.

LEGISLATION

Mr. Ryan Edmonson provided the board members with information.

RECORDS MANAGEMENT

Ms. Susan I. McLellan was present to speak before the Board. Mr. Ryan Edmonson, the Executive Director explained the records management process and gave examples for records request and response timelines to subpoenas. Mr. Ryan Edmonson also spoke about retaining records. Ms. Susan I. McLellan spoke about subpoenaed records and providing the requested records from the Arizona State Board of Dental Examiners. She also spoke about A.R.S. § 32-1264, A.R.S. § 32-1264(E) and A.R.S. § 12-2297 and stated examples for each. The Board asked Ms. Susan I. McLellan about obtaining records from LLC's and dentists and the importance of maintain records for patients. Ms. Heather N. Hardy made a motion to form a committee for rules and law changes consisting of seven (7) members, four (4) board members. Ms. Heather N. Hardy selected Ms. Marilyn McClain, Dr. Russell Morrow, Mr. Nick Goodman, Mr. Aditya Dynar and three (3) public members, seconded by Dr. Robert B. Taylor. The motion passed unanimously 10 - 0.

DENTAL ASSISTANTS' SCOPE OF PRACTICE

Dr. Russell Morrow spoke about dental assistance taking dental impressions for dentist. He believes the doctor should be submitting the impressions. Board members discussed the new age equipment that is available for dental impressions and that the law needs to be updated due to digital age. Ms. Mary DeLaat Williams stated R4-11-702. Russell J. Morrow moved to draft a substantive policy to address the taking of final impressions of the dental assistance and the doctor's requirements on legality of who can take impressions, seconded by Mr. Nick Goodman. The motion passed unanimously 10 - 0.

STANDARDIZED METHOD FOR DOCTOR REMEDIATION

Dr. John Dovgan was present to speak and distributed information. Dr. John Dovgan stated his background and spoke about his course titled, Forensic Dentistry and The Standard of Care: Risk Management, Record Keeping and Ethics in Dental Practice. The Board discussed Dr. John Dovgan's course and it being approved for dentists. The Board asked the investigator to review the course. Ms. Heather N. Hardy tabled the matter for more information and would like to continue the discussion of the course at the next board meeting, October 4, 2019.

EXECUTIVE DIRECTOR'S REPORT

A. Budget Update

Mr. Ryan Edmonson discussed the board's budget. Mr. Ryan Edmonson also provided a budget report for the members.

B. Agency Operations

Mr. Ryan Edmonson spoke about the agency contracting with a rule writer. Mr. Ryan Edmonson also spoke about the board meetings being longer and proposed monthly meetings. The members discussed the possible monthly board meetings.

C. Hiring an Investigator

Mr. Ryan Edmonson informed the Board that they will be hiring a board investigator since the current investigator will be retiring. The job has been posted and the Board may have to form a committee to interview the candidates. The position will be part-time.

SUMMARY OF CURRENT EVENTS

Revisiting the tele-dentistry and orthodontics but had to pull item because of conflict of interest.

DISCUSSION AND POSSIBLE ACTION ITEMS FOR FUTURE MEETING AGENDAS

Ms. Mary DeLaat Williams will be presenting a training that can be done at another meeting for August 2019. Mr. Ryan Edmonson explained the importance for the training especially with new members and the training being part of Board member requirements. It will be a power point training.

Dr. John N. Harmon spoke about the Audit Committee for continuing education and read from a document he typed out. He explained the importance of submitting continuing education hours and if unable to provide the continuing education hours need to have the dentist explain why and will make the decision to grant an extension for submitting continuing education hours. The board members also discussed placing language in the applications that explains that the dentists will need to submit a document to request an extension for submitting continuing education hours.

Dr. Robert B. Taylor thanked the board's Assistant Attorney General, Ms. Mary DeLaat Williams for all of her hard work. Ms. Mary DeLaat Williams was grateful and assured the members the next Assistant Attorney General, Mr. Seth Hargraves will be properly trained.
