DENTISTS' AND HYGIENISTS' REQUESTS FOR A CONTINUING EDUCATION ("CE") EXTENSION – A.R.S. §§ 32-1236 & 32-1287

The Board members agreed that all application fields need to be filled out, if they answer "yes" to any questions, the applicant will not be granted an extension, and the timeframe for the extension will be case by case. Also, Mr. Ryan Edmonson will put a policy and procedure in place for requested extensions to submit continuing education and take it to the Board for approval and have a link on the Board's website; should anyone have questions about the guidelines for continuing education extension requests.

STANDARDIZED METHOD FOR DOCTOR REMEDIATION
