**III. BOARD TO REVIEW, DISCUSS AND TAKE POSSIBLE ACTION ON THE FORMATION OF A COMMITTEE TO ESTABLISH UNIFORM GUIDELINES FOR THE REVIEW OF INVESTIGATIONS, VIOLATION SUBSTANTIATION, ENFORCEMENT ACTION AND CONSIDERATION OF PRIOR ENFORCEMENT HISTORY**

Based on the Board's review of the Auditor General's Sunset Review Report and subsequent responses, the Board considered forming an ad hoc committee to establish guidelines of consistency and uniformity regarding the review of investigations, violation substantiation, enforcement action and consideration of prior enforcement history.
