I. CALL TO ORDER AND ROLL CALL

The meeting was called to order at 2:35 p.m. by Dr. Herro. Roll call of the committee members was taken and a quorum was established.

II. REVIEW, DISCUSSION AND POSSIBLE ACTION ON COMMITTEE MEETING MINUTES

A. Discussion and approval of the Open Session Minutes from the September 16, 2022 committee meeting.

Motion: Dr. Herro moved to approve the Open Session Minutes from the August 2, 2022 committee meeting.

Second: Dr. Lout

Vote: 7-aye, 0-nay, 0-abstain, 0-recuse, 3-absent. Motion passed.

III. NOTICE OF PROPOSED RULEMAKING (“NPR”)

The Committee began the review of A.A.C. R4-11-1302(R) relating to additional persons present during a procedure. Dr. Caputo addressed the Committee and suggested that “during the critical portion” of the procedure be removed from the NPR. The Committee concurred to further clarify the language.

Dr. Christensen joined the meeting at 2:45 p.m.

The Committee discussed the process other States have regarding Board accepted courses for assistants. Staff clarified that the Board does not have a mechanism to determine what courses are accepted. The Committee proceeded to review R4-11-1303 and discussed revising language related to the level and route of sedation. Dr. Caputo suggested changing the title of Moderate Sedation via Oral Route to Enteral Moderate Sedation. After discussion, the Committee concurred to change the title of 1302 to Parenteral Moderate Sedation and 1303 to Enteral Moderate Sedation. The Committee proceeded to review Subsection A and did not make changes to the current language. Dr. Arnall addressed the Committee and suggested that the Committee add clarifying language to indicate that a permit is not required for the outlined parameters in Subsection A. The Committee also reviewed Subsection B. The Committee concurred to use the evaluation forms to assist in drafting language for the NPR in preparation for the next meeting.
