The meeting was called to order at 2:04 p.m. by Dr. Herro. Roll call of the committee members was taken and a quorum was established at 2:10 p.m.

#### III. NOTICE OF PROPOSED RULEMAKING ("NPR")

The Committee reviewed A.A.C. R4-11-1302 to address pending comments throughout the rule. During the review of Subsection H, the Committee amended the language to further clarify the use of intraosseous access during emergency situations. The Committee proceeded to review A.A.C. R4-11-1303 pertaining to Enteral Moderate Sedation and discussed multiple doses. Dr. Caputo provided the Committee historical information and stated that restricting a dentist to a single dose administration could cause potential issues with the provider going to the highest possible dose vs trying a lower dose. The Committee further discussed adding language to clarify that a permit holder that brings in a CRNA or a physician must ensure that the provider meets the requirements of a 1304 Permit holder pertaining to the pediatric endorsement when treating pediatric patients.

The Committee proceeded to discuss making a new section applicable to all dental professionals who do not hold a permit, to allow incremental dossing. The Committee further reviewed the language in Section 1303 and concurred to consider defining a recognized continuing education course at a future meeting.
