Dr. Arnall informed the Board that he met with stakeholders and they agreed on language that clarifies that a dentist who is a Section 1301, 1302 and 1303 Permit holder may work with any QAP without needing to notify the Board. It also clarifies that a non-permit holder may work with any QAP if the dentist signs an affidavit that states that the QAP will follow the rules that apply to them. When utilizing a QAP and treating a patient less than 8 years of age, the QAP will follow the pediatric endorsement rules in their applicable section. In addition to having an attestation, the licensed dentist involved in the case, shall submit a form with the QAP’s information. After discussion, the Board considered it prudent to discuss the proposed language at a future meeting.
