The committee reviewed the list of candidates for the vacant position and expressed interest in having a prosthodontist fill the position. After discussion, the committee concurred to have a committee member reach out to the candidates to explain the time commitment for the position and verify if they are still interested. The committee also concurred to recommend that the board select one of the two prosthodontists and if they are not interested, to recommend that the board select one of the general dentists from the list.

The committee reviewed the board's open complaints.

## VIII. SUMMARY OF CURRENT EVENTS

Mr. Edmonson informed the committee that the board received a continuation recommendation for six-years and stated that a legislative matter that is being reviewed this year includes a dental compact, which affects both dentists and dental hygienists. In addition, Mr. Edmonson provided the committee an overview of the common pitfalls quiz that was sent to all licensees.
